Chapter 301 (Amend 1994)

INSTRUMENT OF BOARD MEMBERS APPOINTMENT

I, **FRANCIS AWESA**, Minister for Works & Implementation, by virtue of powers conferred by Section 7 of the *Building Act* (Amend 1/1/1994) and all other powers enabling, hereby:—

- (a) Revoke all previous appointments of the members of the National Capital District Building Board; and
- (b) Appoint each person specified in Column 2 of the Schedule to be a member of the National Capital District Building Board specified to be member of the Building Board specified in Column 1 and set out opposite the name of that person; and
- (c) Appoint each person specified in Column 3 to be alternate member on the Board for the member specified in Column 2 and set out opposite the name of that member; and
- (d) Appoint each person specified in Column 2 of the Schedule against whose name appears the word “**Chairman**” to be the Chairman of this Board; and
- (e) Appoint the person specified in Column 2 of the Schedule against whose name appears the word “**Deputy Chairman**” to be the Deputy Chairman of this Board; and
- (f) Approve the term of this Board to be three (3) Years from the date of this notice; and
- (g) Fix the quorum for the National Capital District Building Board at four (4).
