### APPOINTMENT OF MEMBERS OF THE NATIONAL ECONOMIC FISCAL COMMISSION

I, **THEODORE ZURENUOC**, Acting Governor-General, by virtue of the powers conferred by Section 187H of the Constitution, and Section 117 of the *Organic Law on Provincial Governments and Local-level Governments (Organic Law)* and Section 3D of the *National Economic and Fiscal Commission (Amendment) Act 2009*, and all other powers me enabling, acting with, and in accordance with, the recommendation and advice of the Minister for Public Service, on recommendation of the Public Services Commission, hereby appoint **Dr. Alphonse Gelu** and **Uvenama Roa** as members of the National Economic Fiscal Commission, for a period of four (4) years, commencing on and from 12th October, 2015.
