SOUTHERN HIGHLANDS PROVINCE

Variation to the area and the Constitution of Ialibu Basin Rural Local-Level Government within Imbongu Open Electorate in Southern Highlands Province.

WHEREAS by proclamation (hereinafter referred to as "the said Proclamation") made under the *Organic Law on Provincial Governments and Local-Level Governments* dated the 10th of July 1997, and published in the *National Gazette* No. G149 of 18th day of February 1998, Ialibu Basin Rural Local-Level Government within Imbongu Open Electorate in Southern Highlands Province was established in and for the area described in the Schedule to the said Proclamation.

AND WHEREAS in the said Proclamation certain declarations were made concerning the area and the Constitution of the said Rural Local-Level Government;

AND WHEREAS it is desired to vary the area in and for which the said Rural Local-Level Government was established and to further vary the declarations made concerning the Constitution of the said Rural Local-Level Government;

AND WHEREAS Section 28 of the *Organic Law on Provincial Governments and Local-Level Governments* provides that a Local-Level Government shall not be abolished or in any way amalgamated and its area shall not be altered, without the prior consent of the National Executive Council and of the Provincial Assembly;

NOW THEREFORE, I, MICHAEL OGIO, GCMG, K. St. J., GOVERNOR GENERAL, by virtue of the powers conferred by Sections 27(1) and 28 of the *Organic Law on Provincial Governments and Local-Level Governments* and all other powers me enabling, acting with, and in accordance with, the advice and with the prior consent of the National Executive Council and the Southern Highlands Provincial Assembly, hereby proclaim and declare that:

- (A) The boundaries of the Ialibu Basin Rural Local-Level Government shall comprise of wards and census units as described in the Schedule of this Proclamation.
- (B) The said Rural Local-Level Government shall be divided into twenty-eight (28) Wards.
- (C) The said Rural Local-Level Government shall be constituted of thirty (30) members of which, twenty-eight (28) ward councillors are elected, one to each ward, and two (2) are nominated in accordance with Section 29(1)(d) of the *Organic Law on Provincial Governments and Local-Level Governments*, and
- (i) by repealing Wards 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21 and all the descriptions relating to their respective census divisions and census units and replacing them with the following particulars:

ABOLITION OF LOWER MENDI RURAL LOCAL-LEVEL GOVERNMENT WITHIN IMBONGU OPEN ELECTORATE IN SOUTHERN HIGHLANDS PROVINCE

WHEREAS Section 28 of the *Organic Law on Provincial Governments and Local-Level Governments* provides that a Local-Level Government shall not be abolished or in anyway amalgamated and its area shall not be altered, without the prior consent of the National Executive Council and of the Provincial Assembly;

NOW THEREFORE, I, GRAND CHIEF SIR MICHAEL OGIO, GCL, CGMG, K. St. J., GOVERNOR-GENERAL, by virtue of the powers conferred by Section 28 of the *Organic Law on Provincial Governments and Local-Level Governments* and all other powers me enabling, acting with, and in accordance with, the advice of and prior consent of the National Executive Council, and the Southern Highlands Provincial Assembly, hereby abolish the Lower Mendi Rural Local-Level Government as established by Proclamation dated 10th July, 1997.

ESTABLISHMENT OF UNDIRI RURAL LOCAL-LEVEL GOVERNMENTS WITHIN THE IMBONGU OPEN ELECTORATE IN SOUTHERN HIGHLANDS PROVINCE

WHEREAS Section 27(1) of the *Organic Law on Provincial Governments and Local-Level Governments* provides that the Head of State, acting on the advice of the National Executive Council, may, by Proclamation, establish a Local-Level Government in and for the area described to this Proclamation.

- (A) The boundaries of Undiri Rural Local-Level Government shall comprise of Wards and Census Divisions and Census Units as described in the Schedule to this Proclamation.
- (B) The said Local-Level Government shall be divided into twenty-three (23) wards.
- (C) The said Rural Local-Level Governments shall be constituted of twenty-five (25) members of which twenty-three (23) ward councillors are elected one to each ward and two appointed in accordance with Section 29(1)(d) of the *Organic Law on Provincial Governments and Local-Level Governments Act*.
- (D) This Rural Local-Level Government shall come into operation on the day following the date fixed for the Return of Writs for the 2017 Local-Level Government General Elections.

NOW THEREFORE, I, MICHAEL OGIO, G.C.M.G.C., MG, K. St. J, by virtue of the powers conferred by Section 27(1) of the *Organic Law on Provincial Governments and Local-Level Governments* and all other powers me enabling, acting with, and in accordance with the advice of the National Executive Council, declare Kambiri Rural Local-Level Government within Imbongu Open Electorate, as a Rural Local-Level Government, AND I DO FURTHER DECLARE THAT:—

- (A) The boundaries of the Kambiri Rural Local-Level Government shall comprise of Wards and Census units as described in the Schedule to this Proclamation.
- (B) The said Local-Level Government shall be divided into nineteen (19) wards.
- (C) The said Rural Local-Level Government shall be constituted of twenty-one (21) members of which nineteen (19) ward councillors are elected one to each ward and two (2) are nominated in accordance with Section 29(1)(d) of the *Organic Law on Provincial Governments and Local-Level Governments*.
- (D) The said Rural Local-Level Government shall come into operation on the date of the Return of Writs for the 2018 Local-Level Government General Elections.
