EXEMPTION ON OVERSEAS REPORTING COMPANIES BY THE REGISTRAR OF COMPANIES FROM AUDITING, PREPARING AND LODGING BRANCH ACCOUNTS

I Harriet Kokiva, Registrar of Companies, by virtue of the powers conferred on me pursuant to Section 390 (8) of the *Companies Act 1997* (Part XX) and Section 58 (4) of the *Companies Regulation 2015*, and all other powers me enabling, hereby grant exemptions to the following companies from auditing, preparing and lodging with the Registrar of Companies separate accounts for its Papua New Guinea branch operations.

These exemptions shall take effect in retrospect to various dates on which formal notices were originally issued to these listed companies.
