- (c) in Schedule 31 (**MINISTER FOR LANDS AND PHYSICAL PLANNING**)—

 - (ii) Column 3, by inserting “(d) APEC” and
 - (iii) Column 4, by inserting “*APEC Papua New Guinea 2018 Coordination Authority Act 2014*; and
 - (iv) by deleting the Title and inserting the following new title”
- MINISTER FOR LANDS, PHYSICAL PLANNING AND APEC”.**
