*Organic Law on Provincial and Local-Level Governments**Public Services (Management) Act 2014***REVOCATION OF APPOINTMENT AND APPOINTMENT OF ACTING ADMINISTRATOR FOR SANDAUN PROVINCIAL ADMINISTRATION**

I, **GRAND CHIEF SIR BOB DADAE.**, GCL., G. C. M. G., K. St. J., Governor General, by virtue of the powers conferred by Section 73(2A) of the *Organic Law on Provincial and Local-Level Governments* and Section 61 of the *Public Services (Management) Act 2014*, and all other powers me enabling, acting with, and in accordance with, a recommendation from the Sandaun Provincial Executive Council, hereby—

- (a) revoke the appointment of **HENRY NORM** as Provincial Administrator for Sandaun Provincial Administration as published in the *National Gazette* No. G485 of 5th July, 2017; and
- (b) appoint **HENRY NORM** as Acting Provincial Administrator for Sandaun Provincial Administration with effect on and from 30th July, 2017 up to and including 12th October, 2017; and
- (c) revoke the appointment of **HENRY NORM** as Acting Provincial Administrator for Sandaun Provincial Administration with effect on and from 12th October, 2017.
