Migration Act (Chapter 16)

EXEMPTION ON ENTRY PERMIT

I, **PETRUS THOMAS**, Minister for Immigration and Border Security, by virtue of the powers conferred by Section 20 of the *Migration Act* (Chapter 16), and all other powers me enabling hereby exempt at Heads of State, Head of Government, Ministers of State, and Guests of the Government, together with their respective spouses, children and personal staff, attending APEC meetings in Papua New Guinea, from the following provisions of the *Migration Act* (Chapter 16):

- (a) entry power under Section 3; and
- (b) unlawful presence under Section 7; and
- (c) refused entry under Section 8; and
- (d) duties of persons arriving in country under Section 9.

This exemption will cease to apply to a person when all APEC related events cease, or on the 31st December 2018, whichever occurs first.
