## CONSTITUTION

### AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS.

I, **PETER O'NEILL**, Prime Minister, by virtue of the powers conferred by Section 148 of the *Constitution* and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 14th August, 2017 and published in *National Gazette* No. G615 of 14th August, 2017 (as amended)—

- (a) in Schedule 1 (**PRIME MINISTER AND MINISTER FOR SPORTS**)-
  - (i) in the title, by deleting "**PRIME MINISTER AND MINISTER FOR SPORTS**" and inserting "**PRIME MINISTER AND MINISTER FOR SPORTS AND BOUGAINVILLE AFFAIRS.**"; and
  - (ii) in Column 2 by deleting "Prime Minister and Minister for Sports" and inserting "Prime Minister and Minister for Sports and Bougainville Affairs"; and
  - (iii) in Column 3, by inserting the following:

**Amendment of Determination of Titles and Responsibilities of Ministers—*continued***

“(w) All matters relating to autonomy, Bougainville Peace and Restoration Office, and restoration and reconstruction on Bougainville and foreign funding relating to restoration and reconstruction”; and

(iv) in Column 4 by inserting the following:

“ All legislation relating to autonomy and Bougainville matters.”; and

(b) in Schedule 30 (**MINISTER FOR BOUGAINVILLE AFFAIRS**) —

(i) in the title, by deleting “**MINISTER FOR BOUGAINVILLE AFFAIRS**” and inserting “**MINISTER ASSISTING THE PRIME MINISTER**”; and

(ii) in Column 1 by deleting “**SIMON DUMARINU**” and inserting “**WILLIAM SAMB**”; and

(iii) in Column 2 by deleting “Minister for Bougainville Affairs” and inserting “Minister Assisting the Prime Minister and Minister for Sports and Bougainville Affairs”; and

(iv) in Column 3 by—

(A) deleting “All matters relating to autonomy, Bougainville Peace and Restoration Office, and restoration and reconstruction on Bougainville and foreign funding relative thereto”; and

(B) inserting “All matters as delegated by the Prime Minister.” and

(v) in Column 4 by—

(A) deleting “All legislation relating to autonomy and Bougainville matters.”; and

(B) inserting “All legislation as delegated by the Prime Minister.”
