## MINISTERIAL DETERMINATION

### PNG LNG PROJECT PIPELINE LICENSE FOUR (PL No.4) SEGMENT SEVEN (7) LANDOWNER BENEFICIARY IDENTIFICATION (LOBID) AND BENEFIT SHARING ARRANGEMENT

I, the Minister for Petroleum, Hon: Dr. Fabian Pok, MEd, PhD, MP, by virtue of section 169A & 170 of the Oil and Gas Act 1998 (as amended), and all other powers enabling me hereby make the following Determination on the sharing of 44.47% of the 28% apportioned for the PNG LNG Project Pipeline License Areas by the major beneficiaries (Clans) in the Pipeline Corridor, and the Buffer Zone Area of the PNG LNG Project Pipeline License Four (4), Segment Seven (7) Area who are entitled to receive Royalty and Equity benefits.

Having received and considered all submissions before me including; (1) PNG LNG Project Umbrella Benefits Sharing Agreement, (2) PNG LNG Project Pipeline Licensed Based Benefits Sharing Agreement, and; (3) Internal Department of Petroleum Review Reports for the purpose of s.169; I, the Minister responsible for the implementation of the Oil & Gas Act 1998 (as amended) make the following determinations:

1. Appearing on Schedule 1 are the Major Beneficiary Tribes and their benefit splits in the PNG LNG Project Pipeline License Four (4), Segment Seven (7) Area
2. Appearing on Schedule 2 are the Major Beneficiaries (Clans) under the Tribal groups mentioned in Schedule 1 in the Pipeline Corridor Area and their Benefit Splits who are entitled to receive royalties & equities in accordance with the benefit sharing mechanism as shown on this Determination.
3. Appearing on Schedule 3 are the Major Beneficiaries (Clans) in the Pipeline Buffer Zone Area under the respective Tribes as appearing on Schedule 1 and their Benefit Splits who are entitled to receive royalties & equities in accordance with the benefit sharing mechanism as shown on this Determination.

Where appearing Hawamere and Waterways Clans means that the Major Beneficiaries (Clans) will be identified by the tribal leaders during the Accounts Opening Process and the Sharing Mechanism will be subject to the consent of the Major Beneficiaries (Clans) impacted under the Pipeline Corridor.
