Public Finances (Management) Act 1995

APPOINTMENT OF SECTION 32 OFFICERS

I, **BETTY PALASO, OBE**, Commissioner General of Internal Revenue Commission, by virtue of the powers conferred by Section 32(1) of the *Public Finances (Management) Act 1995* and by all powers me enabling, hereby appoint the following officers to be Section 32 Officers for their respective offices as follows:

B. CONDITIONS

The following conditions apply:

1. The Commissioner General can approve purchase requisitions for all divisions where it exceeds K150,000. Approvals coming to the Commissioner General should be supported by a Commissioner or the Chief Financial Officer.

2. The Commissioner Taxation can approve purchase requisitions for all divisions in the Taxation wing up to their delegated limit if the Assistant Commissioner is away or the request exceeds the Assistant Commissioners delegated limits.

In such instances, the Commissioner of Tax is delegated as a Section 32 Officer as described below:
