PART IV—PROVINCIAL PHYSICAL PLANNING BOARDS

- . Chief Inspector George Bayagau, PPC, the member appointed by the Minister in accordance with Section 20(a) of the *Physical Planning Act*; and

In respect of Section 20(1)(g)

- Morris Alaluku, appointed to represent professions related to physical planning, registered surveyor, registered architect, registered engineer or lawyer; and

- (ii) Churches — Pastor Lenden Butuna; and
- (ii) Settlements — Jonathan Sowelu

In respect of Section 20(5)(a)

- (ii) Marjella Lopi, Area Manager, Huhu Local Level Government, representing the Huhu Local Level Government due to the extension of the Alotau Town Physical Planning Boundary.
