CORRIGENDUM

It is hereby notified for general information that the notice of appointment of members and alternate members of the Accountants Registration Board of Papua New Guinea, published in the *National Gazette* No. G59 of 31st January, 2019 contained an error—

- (a) the sentence in paragraph one “**I, Peter O’Neill, Prime Minister, by virtue of the powers conferred by Section 5 and 6 of the *Accountants Act 1996* and all other powers me enabling me, hereby appoint—**” is incorrect; and
- (b) it should read “**I, Peter O’Neill, Prime Minister, by virtue of the powers conferred by Section 5 and 6 of the *Accountants Act 1996* and all other powers me enabling, hereby appoint—**”
- (c) the words in paragraph (b) “**each person specified in Column 3 of the Schedule as an alternate member of the member of the Board specified in Column 2 of the Schedule opposite his name, for a period of two years commencing on and from the date of publication of this Instrument in the *National Gazette*”** is incorrect; and
- (d) it should read (b) “**each person specified in Column 3 of the Schedule as an alternate member of the member of the Board specified in Column 2 of the Schedule opposite his name, for a period of three (3) years commencing on and from the date of publication of this Instrument in the *National Gazette*”.**
