## PART IV PROVINCIAL PHYSICAL PLANNING BOARD

the member appointed by the Minister in accordance with Section (20)(a) of the *Physical Planning Act*; and
- In respect of Section (20)(1)(g) — **Paul Robert**  
appointed to represent professions related to physical planning; and
- In respect of Section 20(1)(h) — **Fr Gabriel Tovo** appointed to represent churches; and  
(Optional) **Jackson Endo** — Settlement; and  
(Optional) **Maria Ante** — represent Women, youth and sports

The above mentioned members, in respect of Section 20(1)(e), (f), (g) and (h), are appointed for a period of three (3) years (up to three years) from the date of this notice.
