REVOCATION OF APPOINTMENT AND APPOINTMENT OF CHAIRMAN & DEPUTY CHAIRMAN OF THE MEDICAL BOARD

I, **Honourable Elias Kapavore, Minister for Health and HIV/AIDS, MP**, by virtue of the powers conferred by Section 5 and Sub-Section 1 of the *Medical Registration Act, 1980* (Chapter 398) and all other powers me enabling hereby:—
