DEPORTATION ACT

(Cap. 58)

DEPORTATION ORDER - STATEMENT OF FACTS

WHEREAS WILLIAM ERNEST JOHNSON is a person, not exempted under section 7 of the Immigration Act (Cap. 60), is not the holder of a valid permit issued under the said Immigration Act.

AND WHEREAS the presence of the said WILLIAM ERNEST JOHNSON is unlawful by virtue of section 11 (1) of the said Immigration Act.

AND TAKE NOTE that the particulars of the facts against WILLIAM ERNEST JOHNSON or upon which this ORDER is made are as follows;-

- 1. That you are a foreign national from Australia
- 2. That the residency permit issued to you valid until 23 JAN 2005 is now expired
- 3. That when your residency permit was expired on 23 JAN 2005 no application neither you lodged such application for a further renewal
- 4. That after the expiry of your residency permit you were not issued with any permit to reside in the country and that your presence in the country is now unlawful under section 13 of the said Immigration Act
- 5. That a result of your residing in the Solomon Islands without a permit, you are a prohibited immigrant under section11(1) of the said Immigration Act
- 6. That as a result of you being a prohibited immigrant under section 11(1) of the said Immigration Act, you are being issued with this Deportation Order under section 4 (d) of the Deportation Act (Cap. 58) as read with section 14 of the said Immigration Act

NOW THEREFORE pursuant to section 4 of the said Deportation Act as read with section 5 (1) of the Deportation (Amendment) Act 1999 and having regard to the particulars stated above, I, Patteson Oti, Minister for Foreign Affairs External Trade and Immigration hereby order the said WILLIAM ERNEST JOHNSON to leave and thereafter remain out of Solomon Islands.

AND pursuant to section 7 (2) (a) (b) of the said Deportation (Amendment) Act 1999, I, hereby authorize and direct any Immigration Officer of Police Officer any time this Order is served on the said WILLIAM ERNEST JOHNSON to place him on board any ship or aircraft leaving Solomon Islands.

AND I further authorize and direct the Officer-in-charge of the Central Prison Rove or any Police Station in Solomon Islands to detain the said WILLIAM ERNEST JOHNSON until arrangements are completed for so placing him on board the ship or aircraft.
