ELECTRICITY ACT

(Cap. 128)

ELECTRICITY (CHARGES FOR SUPPLY) (NO. 7) REGULATIONS 2024

I, Hon. Bradley Billy Smoky Rodo Tovosia, Minister for Mines, Energy and Rural Electrification, and I, Hon. Manasseh Damukana Sogavare, Minister for Finance and Treasury, under section 55(v) of the *Electricity Act* (Cap. 128) and with reference to section 26 of the *State Owned Enterprises Act 2007*, on the recommendation of the Solomon Islands Electricity Authority, make the following Regulations:

1 Citation

These Regulations may be cited as the *Electricity (Charges for Supply) (No. 7) Regulations 2024*.

2 Commencement

These Regulations commence on 1 August 2024.

3 Definition**In these Regulations:**

“*non-regular customer*” means a customer who owns a generation facility and is connected through a kilowatt metre.

4 Charges for supply of electricity

The rates of charges for the supply of electricity from Authority public installations:

- (a) for prepaid customers are specified in Schedule 1; and

- (b) for postpaid customers are specified in Schedule 2; and
(c) for non-regular customers are specified in Schedule 3.

5 Repeal

The *Electricity (Charges for Supply) (No. 6) Regulations 2024* (Legal Notice No. 71 of 2024) are repealed.
