Schedule 1

1. This Ordinance may be cited as the Choiseul Province Business Licence Ordinance 1993 and shall come into operation on the date assented to by the Minister in accordance with section 32 of the Provincial Government Act 1981.

Shop title and commencement.

2. In this Ordinance, except where the context otherwise requires:

"Abattoir" means the business of slaughtering cattle, pigs,
chickens or other livestock intended for human
consumption or consumption by domestic animals.

interpre-

- 'Accounting Service' means the business of providing any service, advice or assistance to any person relating to accounting, accounts, taxation and financial matters of any kind and including audit services.
- 'Air Transport Services' means the business of providing transportation services by aeroplane whether for passengers or freight.
- "Authorised Officer" means any Provincial Officer authorised by the Executive to carry out a function or duty under this Ordinance.
- "Bakery" means the business of baking or making of bread, biscuits, rolls, tarts, cakes, pies, scones, confectionary pastries, doughnuts or other baked goods for consumption by persons not residing on the premises on which the baking or making is carried out.
- "Based within Choiseul Province" in relation to any business means a business operating within Choiseul Province which has office premises or branch office premises which promises are located in Choiseul Province.
- "Beach Trading" means the business of hawking from a canoe, ship other vessel.
- "Beach-de-mer Trading" means the business of trading in the species of Holothurians which includes bech-de-mer trepang, sea slugs, or sea cucumber.
- "Bee Keeping" means the busines of keeping bees and hives and includes but is not limited to the selling of honey or any other honey based produce or any product based upon the beekeeping operation.
- "Brick Making" means the business of making small units of of building materials by hardening clay or cement or combining these materials with any other materials or using some other similar materials.
- "Broadcasting Services" means the business of transmitting by radio any message or other matter for information,

education or entertainment to the public within or outside Solomon Islands.

"Building Construction" means the business of building or repairing of buildings but does not include casual building or repairing of buildings by traditional agreement.

"Building Rentals" means the business of leasing, renting or administering the leasing or renting of houses or buildings or the business of acting as agent for the owner of any property in respect of the administration of that property.

"Business" means any activity or undertaking, service, trade, pr of ession or occupation or other ventures determined by the Provincial Executive to be a business within the intent of this Ordinance carried on, undertaken or operated by any person within the boundaries of Choiseul Province for the purpose of gain or profit or for payment of any kind but does not include any activity or service undertaken by an employee in the course of that employee's duties.

"Butchery" means the business of storing, preparing and/or selling or reselling meat.

"Cinema" means the business of showing films or videos and is a business which requires a theatre Licence in accordance with Section 4 of the Cinematograph Act passed in amendment or substitution therefor.

"Clam Trading" means the business of trading in any species of giant clam which includes tridacua gigas, T. darasa, T. aquanosa, T. maximma, T crocea and Hippopus.

"Commodity" means the business of carrying on the exporting of any commodity listed in Schedule 1 of the Commodities Export Marketing Authority Act or any Act passed in amendment or substitution therefor and/or the business of carrying on of an preescribed activity listed in the Notice of Prescribed Activities given under the Commodities Export Marketing Authority Act (LN13/89) or any commodity listed in Schedule I of the Commodities Export Marketing Authority Act or any Act passed in amendment or substitution therefor.

"Consultancy Service" means the business of providing advice or assistance on any matter other than a legal matter.

"Crab Trading" means the business of trading in any species of crab including but not limited to coconut crabs (birgus latro) of mudcrabs (spylla).

- "Crayfish Trading" means the business of trading in crayfish (genues Panulirus) and or lobster.
- "Crocodile Dealing" means the business of crocodile farming and/or buying and/or selling crocodiles and/or the business of buying and/or selling and/or drying, treating or tanning crocodile skins.
- "Diving Service" means the business of providing facilities for scube diving or snorkeling and/or providing instruction and/or training courses in scuba diving and/or the hiring out of equipment for scuba diving or snorkeling.
- "Drafting" means the business of drawing or preparing designs, drawings, plans, diagrams, maps or charts.
- "Dry Coconut Buying" means the business of buying dry coconuts for resale whether or not such coconuts are processed or partly processed at the time of resale.
- "Electrical Service" means the business of installing, repairing, maintaining or removing of any electrical plant, fittings or apparatus but does not include services performed by Solomon Islands Electricity Authority.
- "Electrical Supply Service" means the business of managing and working electrical installations for the transmission and distribution of electrical energy for sale to consumers.
- "Electronics" means the business of building, repairing or maintaining any electronic device including but not limited to radio, video, televisions, computers, word processors, typewriters, tape cassette recorders or photocopiers.
- "Engineering Service" means the business of making any machinary or installing, maintaining or repairing any machine, vehicle, engine or outboard motor but does not include ship repairing.
- "Engineering Works" means the busines of building or repairing structure other than buildings and any othr kind of construction works including but not limited to water tanks, walls, bridges, wharves, town water supplies and sewerage works.
- "Entertainment" means the business of providing entertainment of any kind other than the business of a cinema as herein defined including but not limited to video games and all business coming within the provisions of the Gaming and Lotteries Act and all amendments thereto"."

- "Executive" means the Choiseul province Executive as established under section 22 of the Provincial Government Act 1981 or any other person to whom authority has been properly delegated.
- "Exporting" means the transporting of goods originating from within Choiseul Provinc outside Solomon Islands for the purpose of trade.
- "Fishing Commercial" means the business of operating one or more fishing vessesls and is a business which requires a Licence in accordance with Section 6 of the Fisheries Act 1972 or any Act pased in amendment of substitution therefor.
- "Fish Marketing" means the business of storing fish and/or other seafoods and/or the purchasing of fish and/or other seafoods and/or the selling of fish and/or other seafoods."
- "Fish Processing" means the business operated on land of preserving or preparing fish and/or other sea foods and/or producing any substance or article from fish or other sea food by any method.
- "From outside" in relation to any business means a business operation within Choiseul Province which is not a business based within Choiseul Province.
- "Furniture Manufacture" means the business of making or manufacturing or selling assembled and finished chairs, tables, desks, sofas, couches, shelves, bookcase or any other furniture for household or commercial use.
- "Gold Dealer" means the business of buying or selling or dealing in gold and is a business which requires a licence in accordance with section 49 of the Mining Act or any Act passed in amendment or substitution therefor.
- "Green Snail Trading" means the business of trading in green snails.
- "Hardware" means the business of selling tools and materials.
- "Hawking" means the business of carrying goods for sale, barter or exchange and includes the sale foods, fish or other goods by any person at a place where that person does not usually reside or carry on business but does not include wholesaling.
- 'Hire Services' means the business of hiring goods of any kind and includes but is not limited to the hire of videos, electronic goods, tools, machinery, bicycles and motors vehicles.

- "Hotel" means the business of providing sleeping acommodation and restaurant service from the same premises.
- "Ice-Cream Manufacturing sameans the business of manufacturing and/or selling ice cream and other related products.
- "Logging operations" means the business of using heavy machineries and equipment, such as, but not limited to, dozers, graders, dump trucks, loaders, log trucks, rollers, and excavators, in order to fell and harvest trees for round logs and sawn timbers.
- "Legal Service" nicans the business of providing any advice or assistance on any law or legal matter.
- "Liquor Sales" means the business of selling liquor and is a business which requires a licence in acordance with Section 33 of the Liquor Act or any act passed in amendment or substitution therefor.
- "Manufacturing" means the business of making any product for sale.
- "Medical clinic" means the business of providing medical and/or surgical and/or dental services and/or other health services and/or pharmacy services.
- "Mining" means the business of reconnaissance, prospecting and/or mining of minerals and mineral substances as defined is Section 2 of the Mining Act or any act passed in amendment or substitution therefor and it is a business which requires a licence permit or least under any section of that Act or any act pased in amendment or substitution therefor.
- "Money Lending" means the business of lending money but does not include the business of banking.
- "Pawn Broking" means the business of depositing articles as security for money borrowed.
- "Pearl Oyster Trading" means the business of trading in gold lip pearl shell (Pinetada maxima) and/or black lip pearl oyster (Pinstada margaritifera) and/or brown lipped oyster (Pteria penguin).
- "Person" means any person, persons, company or other group association, co-operative or statutory authority but does not include any government department or the Choiseul Provincial Executive.
- "Pest Control" means the bussiness of providing services and/or pesticides or any other products or form method

of eradication for the control of destructon of pests and vermin.

"Petroleum Storage" means the business of storing for sale any processed petrol or oil product including but not limited to petrol, diesel, kerosene, propane, Speedy Gas, gas and lubricants.

"Photography" means the business of operating a photographic studio or store and/or providing a photographic service and/or the sale or hire of photographic equipment and including but not limited to a developing service for photographic film or slide film.

"Plantation" means the business of the planting, growing, production and sale of timber, copra, cocoa, coffee, palm oil, spices or any other commercial crop by any company as defined in the Companies Act or any act passed in amendment or substitution therefor or by any co-operative society registered under the co-operative Societies Act or any act passed in amendment or substitution therefor.

"Plumbing Services" means the business of installing, repairing, maintaining or removing water pipes, sewers, drains or any apparatus relating thereto.

"Policies of Choiseul Province" means those policies and plans and strategies relating to businesses, functions, services, development and planning within Choiseul Province approved by the Provincial Executive and in force at the or the application for a business licence or any renewal thereof under this Ordinance and published and available to any person upon payment of the prescibed fee.

"Port Services" means the business of providing, operating, improving, maintaining and regulating the use of port facilities.

"Prawn Trading" means the business of trading in prawns including but not limited to harvesting or processing.

"Premises" means any structure, building or part thereof together with the land on which the same is situated and any adjoining land used in connection there with.

"Prescribed Business" mean:

(a) any business listed in Schedule 1 hereof or

(b) any other business, but does not include any business to which Section 3 (2) of the Ordinance applies.

- "Provincial Officer" means any person holding a public Office and seconded to the Choiseul Provincial Assembly or Executive or a person directly employed by Assembly or Executive or a person directly employed by the Choiseul Provincial Assembly or Executive.
- "Provincial Treasurer" means the person holding that public Office.
- "Religious Bookshop" means the business of operating a bookshop selling religious books and/or other religious items by a church or other religious body.
- "Restaurant" means the business of preparing and selling meals by table service for consumption by person not residing on the premises where such preparation or sale takes place.
- "Resthouse" means the business of providing sleeping accomodation.
- "Retail Store" means the business in which merchandise, goods or commodities other than those covered by other definitions within this Section are stocked and sold or offered for sale other than by hawking.
- "Road Transport Service" means the business of providing transportation services by any road vehicle whether for passengers or freight.
- "Road Log Export" means the business of exporting logs or unmilled timber.
- "Rural" means all land outside of the town boundaries of Choiseul Bay and any area declared as such.
- "Saw Milling powered by 25hp or more" means the business of converting unmilled timber into milled timber, using 25hp machine or more including but not limited to sawn timber, wood particles, wood chip, and veneer and is a business which requires a licence in accordance with section 7 of the Forest and Timber Act or any act passed in amendment or substutition therefore or which requires a licence under any other relevant legislation.
- of converting unmilled timber into milled timber, using a machine less than 25hp; including but not limited to sawn timber, wood particles, wood chip, wood pulp and vencer and is a business which requires a licence in accordance with section 7 of the Forest and Timber Act or any Act passed in amendment or substitution therefore or which requires a licence under any other relevant legislation.

- "Sea-weed Trading" means the business of trading in sea-weeds.
- "Sea Transport Service" makes the business of providing transportation services by boat, ship, canoe or other vessel for passengers or freight but does not include transportation by private canoes whereby contributions are made to the cost of the travel.
- "Secretarial Service" means the business of providing secretarial services including but not limited to typing services, wordprocessing services, computer services, photocopying services, filing services or data recording services.
- "Security Service" means the business of providing security of any kind for property and/or goods and/or persons including but not limited to providing secure transportation of goods, selling and/or installing security locks and equipment and systems or alarm systems.
- "Shark Trading" means the business of trading in shark for meat, fins or oil and including but not limited to harvesting and processing.
- "Ship Building" means the business of building repairing or maintaining any ship, boat, vessel or canoe but does not include any wooden canoe.
- "Shipping agency" means the business of being an agent for a shipping line in and out of the Solomon Islands.
- "Shipping Service (Occasional)" means the business of providing transportation services for passengers or cargo by boat, ship or any other vessel but not including a canoe where such boat, ship or other vessel makes no more than four trips to Choiseul Province in any one business licensing year under this Ordinance to conduct its business and which spends no more than fourteen consecutive days conducting its business in Choiseul Province during any one trip.
- "Snack Bar" means the business of preparing and selling food and beverages for consumption by persons not residing on the premises where such preparation or sale takes place and including any such business conducted from a motor vehicle or vessel or caravan.
- "Stevedore Service" means the business in which persons are provided whether by hire or by direct employment to load or unload ships"

"Tailor" means the ousiness of making clothes for sale.

"Timber Exporting" means the business of exporting logs milled or unmilled timber, wood particles, wood chips, pulp and veneer and which is a business which requires a licence in accordance with Section 5 of the Forest and Timber Act or any act passed in amendment or substitution therefor or under any other relevant legislation.

"Timber Felling" means the business of felling trees for sale other than for domestic or agricultural use but does not include any business which requires an Agreement under Part IIA of the Forests and Timber Amendment Act 1977 or any act passed in amendment or substitution therefor.

"Timber Sales" means the business of selling timber unmilled or milled including but not limited to sawn timber, wood particles, wood pulp, venner and any other wood products produced by a timber mill, or purchasing the same for resale.

"Tourist Business" means any business offering sight seeing, recreating or relaxation opportunities to or for tourists but not being a tourist resort or tourist vessel service.

"Tourist Vessel Service" means any business involving the transportation of tourists for the purpose of pleasure of sights seeing aboard a vessel requiring a safety certificate under the Shipping Act or any Act passed in amendment or substitution therefor.

"Tourist Resort" means the business of the provision to tourist or various services and facilities from one premises such as accommodation, restaurant, recreation, transportation, retail store (s) under a single administration and permanent staff.

"Trading" means the business of buying and selling of goods and sevices.

"Trochus Trading" means the business of trading in trochus shells.

"Turtle Trading" means the business of trading in turtle including but is not limited to its shell and meat.

"Urban" means all land inside the town boundaries of Choiseul Bay and any other area declared as such.

"Used Clothing Sales" means the business in which second hand or used clothes are resold.

"Wholesale Store or Warehouse" means the business in which merchandise goods or commodities are stocked and sold or offered for sale to persons businesses or other entities other than the general public for the purpose of resale.

Business to be licenced

- 3(1) No person shall with the boundaries of Choiseul Province operate a prescribed business except under and in accordance with the terms conditions and limitations of a valid business licence issued by the Executive in accordance with Section 5 of this Ordinance.
- 3(2) This Section shall not apply to the following:
 - (i) Occasional fundraising events where the proceeds are used salely for charitable, religious, educational, sporting or other community purposes.
 - (ii) Canteens run by a school or training institute for the use and benefit only of the pupils and students and teacher of that school or training institute.
 - (iii) A business run by an organization, group or association or its members or owners and whose profits are used for charitable, religious, educational, sporting or other community purpose.
 - (iv) Any business activities in the market which for the purposes of this section means any regularly schedule gathering of individuals in a public place to offer goods, foodstuffs or beverages for sale.

Compliance.

- 4. No person shall be granted a business licence unless the business complies with all laws and policies of Choiseul Province.
- 5(1) An application for a business licence shall be made to the Provincial Treasurer on a form prescribed by the regulations.

Application for and issue of Licence.

- 5(2) The applicant must complete the prescribed form and give full particulars of the business for which the licence is required andd the applicant shall supply the Provincial Treasurer with such additional information as he shall require.
- 5(3) In the event that the business for which a licence is sought does not come within one or the categories listed in Schedule I then the Executive shall determine that category and appropriate fee which shall then be applied to all similar applications.

- 5(4) All new business applications to do with investing in harvesting and utilization of the natural resources of the province, as stated in Section IV of the Choiseul Province Investment Management Policy, MUST be considered by the Executive.
- 5(5) The Executive may in its sole discretion refer any application to the Area Council (s) or to the Chiefs or any other body or person representing the local people in the vicinity in which the business in to operate for consideration.
- 5(6) Subject to Section 7 hereof, the Executive may grant a business licence subject to such other terms and conditions and distillations to be thinks fit including but not limited to a modificant connecting the area of operation of the business.
- 5(7) The applicant shall be notified in writing of the decision of the Executive and upon approval of an application the applicant shall be requested to pay the prescribed fee and upon payment of the prescribed fee the Provincial Treasurer or other authorised Officer shall issue to the applicant a business ficence in the prescribed form.
- 5(8) Every licence shall be valid from the date of issue until the 31st day of March next following the date of issue and shall thereupon expire.
- 5(9) The Executive may in its absolute discretion and upon receiving a written request from the applicant grant a licence for a period of two year out any such licence shall be subject to the payment of the annual licence fee on or before the due date and full compliance with the terms and conditions and limitations of the licence and with this Ordinance throughout the term of the business licence.
- regarding whether an activity constitutes a business which must be licensed to ler this Ordinance and the category of licensed to be issued and the prescribed fee shall be final.
- S(11) to licence issued under this Ordinance shall convey or be construed to convey any right, power or authority to enter any private land or reef nor take any action with respect to anything without the authority and permission of the owner(s) of that land or reef c thing.

Combination Licence.

- 6(1) Where a person operates several categories of businesses from one premises, vehicle or vessel that person shall take out a combination business licence in respect of each category of business.
- 6(2) Where a person operate a business in separate premises, vehicles of vessels that person shall take out separate businessd licences in respect of each premises, vehicle and vessel.

Conditions and limitations of licences

- 7(1) No licence holder shall transfer the business licence to any other person or conduct the business on any premises, vehicle or vessel other than that specified in the business licence except in accordance with Section 10 of this Ordinance.
- 7(2) The licence holder shall produce the business licence and receipt for the prescribe fee upon demand from a police officer or any person authorised by the Executive on the production by that prson of his written authority.
- 7(3) The licence holder shall conduct his business in compliance with all relevant Acts of Solomon Islands, Ordinances of Choiseul Province, subsidiary legislation of Solomon Islands and Choiseul Province and all lawful orders of any court, tribunal, commission or statutory body of competent jurisdiction in Solomon Islands.
- 7(4) Where the Executive is satisfied that the licence holder is conducting the business in contravention of the provisions of this Ordinance or in contravention any Acts, subsidiary legislation or lawful orders then the Executive may by notice in writing cancel or suspend the business licence.
- 7(5) Where a business licence is suspended or cancelled under this section the licence holder:
 - (a) shall immediately cease the business in question
 - (b) shall not receive any refund of the licence fee for the balance of the business licence year
 - business licence until the Executive is satisfied that the grounds on which the business licence was suspended or cancelled have been remedied and the business can operate in full compliance with all Acts, subsidiary legislation and lawful orders and all lawful penalties imposd by proper authorities have been satisfied.

8. The Executive shall keep a register of all licence granted.

Register.

The foes for any business licence shall be determined by 9. the Choiseul Provincial Assembly by way of subsidiary legislation PROVIDED HOWEVER that when an application for a business licence is made for a category of business not specified in this Ordinance or any amendment thereto then the Executive shall determine an interim fee for that business to be paid by the applicant to enable the licence to be issued, such fee to remain in force for that category of business until the Choiseul Provincial Assembly shall determine the appropriate fee. Should the fee determined by the Choiseul Provincial Assembly be different from that determined by the Executive then Choisuel Province will make a refund to or collect any additional licence fee from the bussiness licence holder (s) for that category or business as appropriate.

Fees.

9. (2) The fees for any business licence may be reviewed annaually.

Transfer

10. Upon payment of the prescribed fee a business licence holder may transfer the business licence to another person or the Executive may permit the business to operate from other premises, vehicle or vessel or in another area of operation provided always that the business shall still comply with the terms and conditions of the business licence and with this Ordinance.

Duplicate Licence

11. Any holder of a licence issued under this Ordinance whose licence has been lost or destroyed or damaged may on payment of the prescribed fee obtain a duplicate licence from the Executive.

Powers of Police Officers and Authorized Persons.

12. It shall be lawful for any police officer or any person authorised by the Executive on production of his written authority at all reasonable times to demand from a person operating a business the production of any business licence for inspection an to make such enquiries as he thinks fit to ascertain whether any branch of this Ordinance of the licence has been committed.

Penalties

- 13(1) Any person who operates or conducts a prescribed business with Choiseul Province in contravention of this Ordinance shall be guilty of an offence and liable to:
 - (a) a fine not exceeding \$200.00 or fine not exceeding twice the amount of the prescribed licence fee for one year for that category of business, whichever shall be the greater; and
 - (b) a further fine not exceeding \$20.00 for each day on which the offence is continued after written notification of the offence has been given to the offender:

In default of payment of the said fines the offender may be imprisonment for a period not exceeding three months; and/or

- (c) imprisonment for up to six month; and
- (d) the amount of the prescribed licence fee from the offender had the person been granted a licence; which fee shall be recoverable as a civil debt.
- 13(2) Any person who obstructs, hinders or resists a police Officer or other authorised person acting in the due exercise of this powers under this Ordinance or makes a false statement to any police officer of any authorised person or refuses or fails without lawful excuse to produce any licence shall be guilty of an offence and liable to a fine of up to \$200.00 or in default of payment to imprisonment for a period not exceeding four weeks.

Delegation of powers.

- 14(1) The Executive may by an instrument in writing authorize any provincial government or public officer to exercise any powers or perform any duties of the Executive under this Ordinance subject to the general directions of the Executive and any conditions prescribed in the instrument.
- 14(2)The Executive may exercise a power or perform a duty not withstanding that such power or duty has been delegated to an authorised officer.
- 15. Subject only to section 9 hereof the Executive may make such Orders and Regulations as appear to them to be necessary or expedient for carrying out the objectives and provisions of this Ordinance and in particular (without prejudice to the foregoing) such Orders and Regulations may:
 - (a) prescribe the forms and contents of any application, certificate, licence or authority required by this Ordinance.
 - (b) provide for the manner of appointment and the duties and powers of persons authorised to enforce and carry out the provisions of this Ordinance and its Regulations and Orders.
 - (c) prescribe fees and matters relating to fees.

Subsidiary

16. This Ordinance shall be in addition to and shall not derogate from any other Odinance.

Other Ordinances pol derogated.

 Subject to Section 18 the Western Province Business Licence (Amendment) Ordinance 1989 and its subsequent amendments is hereby repealed, in so far as it applies to Choiseul Province.

Repeal.

18. The repeal made by Section 17 does not exempt any person who is or has been liable to obtain a business licence or pay a business licence fee or any part of it, and the repeal made by Section 17 does not prevent the Executive from collecting any such licence fee or any part of it or do any thing permitted by that enactment which the Executive under that enactment are authorised or permitted to do.
