## THE CHOISEUL PROVINCE BUSINESS LICENCE REGULATIONS 2008

Made by Choiseul Provincial Executive on the 16th December 2008 and Approved the Choiseul Provincial Assembly

#### HON. JACKSON KILOE Premier

IN exercise of the powers conferred by Section 15 of the Choiseul Province Business Licence Ordinance 1993 the Choiseul Provincial Executive made the following Regulations.

- 1. These Regulations may be cited as the Choiseul Province Business Licence Regulations and shall come into force on the date of their publication in the Gazette.
- 2. In these Regulations unless the context otherwise requires "Ordinance" means the Choiseul Business Licence Ordinance 1993.
- 3. An application for a business Licence must be in the form set out in Schedule 1.
- 4. An application for renewal of a business licence must made in the form set out in Schedule 2.
- 5. An application for a transfer of a business licence must be made in the form set out in Schedule 3.

- 6. An application for a duplicate of a business licence must be made in the set out in Schedule 4.
- 7. A business licence issued under the Ordinance may be in the set out in Schedule 5 or in such other form or with such amendments, as the Executive shall decide.
- 8. A duplicate business licence issued under the Ordinance shall be a copy of the copy held in the Choiscul Province register of Business Licences and shall be stamped or marked in pen with the word "DUPLICATE".
- 9. Upon the transfer of a business licence to a new licence holder the original licence and the duplicate copy held in the Choiseul Province Register of Business Licence shall be stamped or endorsed in the form set out Schedule 5.
- 10. Upon the transfer of a business licence to permit a licence to permit a licence holder to operate the business from new premises or in a different area the original licence and the duplicate copy held in the Choiscul Province Register of Business Licence shall be stamped or endorsed in the form set out in Schedule 7.
- 11. The fees for any prescribed business are set out in Schedule 8.
- Where a combination of categories of prescribed business are operated upon one premises the fees payable are the prescribed fees set out in Schedule 8.
- 13. Where a business licence is granted for period of time less than one year the fee Payable in the annual fee divided by twelve and multiplied by the number of months for which the licence is granted.
- 14. An application for petroleum storage business licence must specific in the application form the maximum quantity of petrol or other product referred to in the definition of' Petroleum Storage" in the ordinance to be stored at any time during the licence year by the holder.
- 15. The renewal of licence shall the responsibility of the licence holder, however, Schedule 9 will be processing the implementation of the outstanding licence fees.
- 16. The Choiseul Province Business Licence Regulation 1997 are revoked.

#### PRESCRIBED BUSINESS OUTSTANDING LICENSE PAYMENT PROCESS

- 1. All business licenses MUST be paid to the Provincial Treasury on the first working day of each financial year of the Choiseul Province.
- 2. It is the responsibility of the Business license holder to renew its business license on the first working day of each financial year.
- 3. First reminder will be issued to the Business license holder on the 30th April each year. If 30th April falls on an excluded then the first reminder will be issued on Friday of that weekend.
- 4. Fourteen days after the issue of the first reminder, the second and final remainder will be issued to Business license holder.
- 5. Seven days after the issue of the second and final reminder, Business license will be suspended.
