**SOLOMON ISLANDS INDEPENDENCE ORDER  
(LN No. 43 of 1978)****THE ORDER OF SOLOMON ISLANDS (AMENDMENT)  
REGULATIONS 2016**

**IN** exercise of powers conferred by statute xx (b) of the Royal Warrant instituting the Order of Solomon Islands 1981, **I, SIR. FRANK UTU OFAGIORO KABUI**, Knight Grand Cross of the Most Distinguish Order of Saint Michael and Saint George, Cross of the Order of Solomon Islands, Officer of the Most Excellent Order of the British Empire, Governor-General and Commander-in-Chief of Solomon Islands, do hereby make the following Regulations:

1. These Regulations may be cited as the Order of Solomon Islands (Amendment) Regulations 2016.
2. The Order of Solomon Islands Regulations 1981 (“the Principal Regulations”) are hereby amended as follows:
  - (a) by deleting regulation 10 and substituting therefor the following:
    - (1) The Secretary to the Prime Minister (“SPM”) or his or her nominee shall be the Secretary to the Committee.
    - (2) The Private Secretary to the Governor-General (“PS”) or his or her nominee shall be the Co-Secretary to the Committee.
    - (3) The SPM and PS or their nominees shall not be members to the Committee and their functions and duties shall be limited to matters administrative in nature”; and
  - (b) by inserting immediately after regulation 18 the following regulation:
19. The rates for sitting allowances and gratuity payments to the members shall be as out in the Schedule hereto:
