THE TRAFFIC (AMENDMENT) REGULATIONS 1997

IN exercise of the powers conferred by section 81 of the Traffic Act, the Minister hereby makes the following regulations -

1. These Regulations may be cited as the Traffic (Amendment) Regulation 1997.

2. The Traffic Regulations are hereby amended by deleting the First Schedule\* thereto and substituting therefor the following new Schedule -

5. All public service vehicles and taxis shall be inspected at the end of every three (3) months after the last inspection and the inspection fee payable shall be as prescribed in paragraph (4) above.

6. Except as provided for in the Act or in these Regulations, the fees listed in paragraphs (1) to (4) are annual fees payable in respect of the matters listed in those paragraphs."
