PRICE CONTROL ACT

(No. 6 of 1982)

THE PRICE CONTROL (APPLICATION TO GOODS AND
RESTRICTION OF PRICES) (AMENDMENT) (NO. 3)
ORDER 1996

IN Exercise of the powers conferred by sections 4 and 6 of the Price Control Act, 1982, and after consultation with the Prices Advisory Committee, The Minister of Finance, do hereby make the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 3) Order, 1996, and shall come into effect on 17 May 1996.
2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987* is hereby amended by deleting serial No. 13 and substituting therefor the following -
