(No. 13 of 1972)

THE FISHERIES (AMENDMENT) REGULATION 1997

IN exercise of the powers conferred by section 20 of the Fisheries Act, 1972, I, VICTOR NGELE, Minister of Agriculture and Fisheries, do hereby make the following Regulations -

1. This Regulation may be cited as the Fisheries (Amendment) Regulation 1997.

Citation.

2. The Second Schedule* to the principal Regulations is hereby amended as follows -

THE SHIPPING (NOTIFICATION) REGULATION 1997
