(Cap. 14)

**THE LOCAL GOVERNMENT (ENLARGEMENT OF TIME)**  
**(WESTERN PROVINCE) ORDER 1997**

IN exercise of the powers conferred by section 18 of the Local Government Act, I, OLIVER ZAPO, Minister for Home Affairs, do hereby make the following order -

1. This Order may be cited as the Local Government (Enlargement of time) (Province) Order 1997.
2. The period for the registration of voters in Western Province is hereby extended to thirty (30) days of from the date hereof.
