AGRICULTURE QUARANTINE ACT
 (Cap.34)

**THE AGRICULTURAL QUARANTINE
 (AMENDMENT) ORDER 1999**

IN exercise of the powers conferred by sections 2 and 7 of the Agricultural Quarantine Act, the Minister of Agriculture and Fisheries hereby makes the following Order -

1. This Order may be cited as the Agricultural Quarantine (Amendment) Order 1999.
2. The Agricultural Quarantine Order is hereby amended by deleting therefrom Schedule 4 and substituting therefor the following new Schedule:-
