**THE MINES AND MINERALS ACT
(Cap. 42)**

**THE MINES AND MINERALS (AMENDMENT)
REGULATION 1999**

IN exercise of the powers conferred by section 80 of the Mines and Minerals Act, the Minister of Energy, Mines and Minerals hereby makes the following regulations -

1. This Regulation may be cited as the Mines and Minerals (Amendment) Regulation 1999.

2. Regulation 68(4) of the Mines and Minerals Regulations* (herebyafter referred to as the "principal Regulation) is hereby amended by deleting the word "caprious" and substituting therefor the word "capricious".

3. The principal Regulation is hereby amended by adding therein a second schedule -

 - and for each additional square kilometre of part thereof in excess of 20 square kilometres \$50.00

 - (ii) for the second year \$4,000.00
 - and for each additional square kilometre or part thereof \$60.00

 - (iii) for the third year, \$5,500.00
 - and for each additional square kilometre or part thereof in excess of 20 square kilometres \$70.00

 - (iv) for the fourth year, \$7,000.00
 - and for each additional square kilometre or part thereof in excess of 20 square kilometres \$80.00

- (v) for each subsequent year a fee 25% more than the fee for previous year plus for each square kilometre in excess of 20 kilometres

In the fifth year, \$50.00 and in each subsequent year, \$20.00 more than the previous year.

Provided that -

(a) on the commencement of a mineral right all rent payable for the current rental period shall be paid by the holder on the notification of the grant of such tenement; and

(b) where a mineral right commences or expires during a year rental period the Director may waive or remit a proportionate part of the rent payable for that year rental period.
