**CUSTOMS AND EXCISE ACT  
(Cap. 121)**

**THE CUSTOMS AND EXCISE (EXPORT DUTIES)**

**(AMENDMENT) (NO.2) ORDER 2002.**

IN exercise of the powers conferred by section 7 of the Customs and Excise Act, I, LAURIE CHAN, Minister of Finance, do hereby make the following Order:-

1. This Order may be cited as the Customs and Excise (Export Duties) (Amentment) (No.2) Order 2002, and shall come into force on the date of publication in the Gazette.
2. That part of the First Schedule to the Customs and Excise Act entitled "EXPORT CLASSIFICATION AND TARRIFF" is hereby amended by deleting item number 4403.1320 and the words that appear in respect thereof in the corresponding columns and substituting therefore the following:-
