(1987)****AMENDMENT NOTICE TO HOLD PROVINCIAL ELECTIONS**

IN exercise of the powers conferred by Regulation 9 of the Provincial Assemblies Election Regulations 1987, I, WALTON NAEZON, Minister for Provincial Government and Rural Development do hereby:-

- (a) Appoint the 12th Day of December 2002 as the date for holding Provincial Assembly Elections in Guadalcanal, Malaita, and Temotu Provinces; and
- (b) Appoint the following persons to be Returning Officers for the Elections
