**THE CUSTOMS AND EXCISE ACT  
(Cap. 121)****THE CUSTOMS AND EXCISE (EXPORT DUTIES)  
(NO.3) (AMENDMENT) ORDER 2003.**

IN exercise of the powers conferred by section 7 of the Customs and Excise Act, I SNYDER RINI Minister of Finance, do hereby make the following Order:-

1. This Order may be cited as the Customs and Excise (Export Duties) (Amendment) (No.3) Order 2003 and shall come into force on the date of publication in Gazette.
2. That part of the First Schedule to the Customs and Excise Act entitled "EXPORT CLASSIFICATION AND TARIFF" is hereby amended by deleting tariff items 4403.1110, 4403.1120, 4403.1130, 4403.1310, 4403.1320 and 4403.1330 and the words that appear in respect of each item in the corresponding columns and substituting therefor the following:-

**THE FACILITATION OF INTERNATIONAL ASSISTANCE  
(WEAPONS SURRENDER) NOTICE 2003**

IN exercise of the powers conferred upon me by section 21 of the Facilitation of International Assistance Act 2003, I, SIR REV. JOHN INI LAPLI, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor-General and Commander-in-Chief of Solomon Islands, do hereby make the following Notice.

1. I declare an area comprising all the land territory of Solomon Islands to be a weapons surrender area.
2. Members of the visiting contingent are permitted to possess weapons in the area.
3. The following persons are also permitted to possess weapons in the area:
  - (a) members of the Solomon Islands Police in possession of weapons with the authority of the Commissioner of Police in the course of their duties; and
  - (b) persons holding a current and valid firearms licence issued under section 6 of the Firearms and Ammunition Act in respect of weapons covered by that licence.
4. All persons other than those referred to in paragraphs 2 and 3 are prohibited from possessing weapons in the area.

This Notice may be cited as the Facilitation of International Assistance (Weapons Surrender) Notice 2003.

This Notice comes into effect on 22 August 2003.
