**THE MAGISTRATE COURTS
(INCREASE OF JURISDICTION)
(NO. 1 ORDER 2003)**

IN EXERCISE of the powers conferred on me by Section 27(3) of the Magistrates Courts Act, I SIR (GILBERT) JOHN BAPTIST MURIA, Chief Justice of the High Court of Solomon Islands hereby make the following Order:-

1. This Order may be cited as Magistrates Courts (Increased in Criminal Jurisdiction) (No. 1).
2. LEONARD R. MAINA is hereby invested with jurisdiction to hear and determine any of the offences set out in the Schedule hereto:

1. Any offence under sections 136, 137, 138, 139, 142, 146, 158, 160, 161, 163, 164, 169 and 170 of the Penal Code.

**PRICE CONTROL ACT
(Cap. 64)**

**THE PRICE CONTROL (APPLICATION TO GOODS AND
RESTRICTION OF PRICES) (AMENDMENT) (NO.10) ORDER 2003.**

IN exercise of the powers conferred by sections 4 and 6 of the Price Control Act, and after consultations with the Prices Advisory Committee, I, TREVOR OLAVAE, Minister of Commerce, Employment and Trade, do hereby make the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No.10) Order 2003 and shall come into operation on 1 December 2003.
2. Schedule 3 of the Price Control (Application to Goods and Restriction of Prices) Order 1987* is hereby amended by deleting serial No. 13 thereof and substituting therefor the following: -
