**SOLOMON ISLANDS INDEPENDENCE ORDER 1978
(L.N. No. 43 of 1978)**

**MEMBERS OF PARLIAMENT (ENTITLEMENT) COMMISSION
(AMENDMENT) (NO. 2) REGULATIONS 2004**

IN exercise of the powers conferred by section 69B(2) of the Constitution, the Members of Parliament (Entitlements) Commission hereby makes the following regulations -

1. These Regulations may be cited as the Members of Parliament (Entitlements) Commission (Amendment) (No. 2) Regulations 2004, and shall be deemed to have come into operation on the 1st day of April 2004.

2. Regulation 10 of the principal regulations* is hereby amended by inserting immediately after Regulation 10B the following regulation as regulation 10C as follows -

“meal allowance 10C. All members of Parliament (excluding Ministers) shall be paid a meal allowance at the rate of \$200.00 per day”.
