(Cap. 64)****THE PRICE CONTROL (APPLICATION TO GOODS AND
RESTRICTION OF PRICES) (NO. 12) ORDER 2004.**

IN exercise of the powers conferred by sections 4 and 6 of the Price Control Act, and after consultations with the Prices Advisory Committee, I, WALTON NAEZON, Minister of Commerce, Employment and Trade, do hereby make the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 12) Order 2004 and shall come into operation on 1 December 2004.
2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987* is hereby amended by deleting serial No. 13 thereof and substituting therefore the following -
