**THE CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF SERVICE) ACT  
(Cap. 84)**

**THE CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF SERVICE) (CHIEF JUSTICE) (AMENDMENT) REGULATIONS 2004**

IN exercise of the powers conferred by section 3 of the Constitutional Offices (Terms and Conditions of Service) Act, the Prime Minister hereby makes the following regulations -

1. These Regulations may be cited as the Constitutional Offices (Terms and Conditions of Service) (Chief Justice) (Amendment) Regulations 2004.

2. The Constitutional Offices (Terms and Conditions of Service) (Chief Justice) Regulations\* is hereby amended in the following manner -

(a) in regulation 4, by deleting the figure "\$64,397.18" and substituting therefor the figure "\$110,000.00";

(b) in regulation 7, by inserting a comma immediately after the word "gas" and adding the word "telephone" thereafter;

(c) in regulation 9, by deleting the word "a vehicle" and substituting therefor the words "two vehicles.";

(d) in regulation 12(1), by deleting the figure "US\$55.00" and substituting therefor the figure "US\$250.00.";

(e) in regulation 14, by deleting the figure "\$40.00" and substituting therefor the figure "\$210.00."; and

(f) by inserting immediately after regulation 23 a new regulation 24 as follows -

"Compassionate 24. The Chief Justice shall  
be leave entitled to two return trips either by sea  
or air within Solomon Islands on  
compassionate leave per annum.

(c) in regulation 15, by deleting the figure "\$40.00" and substituting therefor the figure "\$210.00."
