**PRICE CONTROL ACT**  
(Cap. 64)

**THE PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 3) ORDER 2006.**

IN exercise of the powers conferred by section 4 and 6 of the Price Control Act, and after consultations with the Prices Committee, **I, PETER SHANELAGOVAKA**, Minister of Commerce, Employment and Trade, do hereby make the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) No. 3) Order 2006 and shall come into operation on 1st September 2006.
2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987\* is hereby amended by deleting serial No. 13 thereof and substituting therefore the following -
