(Cap. 40)****THE NORTHWEST FOREST LIMITED (EXPORT OF 3000<sup>m3</sup> OF TERMINALIA BRASSII) EXEMPTION ORDER 2006**

IN exercise of the powers conferred by section 4(1)(c) of the Forest Resources and Timber Utilisation Act, the Minister hereby makes the following order -

1. This Order may be cited as the Northwest Forest Limited (Export of 3000<sup>m3</sup> of Terminalia Brasili) Exemption Order 2006, and shall come into force on the date of publication in the Gazette.
2. North West Forest Limited is hereby exempted and permitted to export 3000<sup>m3</sup> of Terminalia Brassii which has been felled from CDC 3 on Guadalcanal Province.
3. The licence to be used for purposes of the export is numbered A10127 deposited with the Commissioner of Forest.
4. The above shipment shall be exported through the vessel MV Hikawa Pride.
5. On the export of this shipment this Order shall cease to have effect.
