THE GOODS TAX ACT
(Cap. 122)**THE GOODS TAX (EXEMPTION) ORDER 2006**

IN exercise of the powers conferred by section 37(2) of the Goods Tax Act, the Minister hereby makes the following Order.

1. This Order may be cited as the Goods Tax (Exemption) Order 2006
2. (a) that **Vatu Enterprises Ltd** shall be granted **100% exemption** from the liability to goods tax on the followings:-
 - (1) 10 units STIHL Chainsaw
 - (2) 10 units STIHL Chainsaw Bar
 - (3) 1 unit Roll Chain
 - (4) 1 unit 30hp Suzuki Outboard Motor
- (b) that the exemptions granted under (a) shall have effect from **21/7/06** and expires on **31/08/06**.
- (c) goods tax exemption Order **No. 00366/06**.
- (d) this exemption Order granted is not transferable.

1. This Order may be cited as the Goods Tax (Exemption) Order 2006
2. (a) that **Solomon Kitano Mendana Hotel** shall be granted **100% exemption** from the liability to goods tax on the followings:-
 - (1) **Per attached listed items from overseas for the renovation of the hotel.**
- (b) that the exemptions granted under (a) shall have effect from **24/6/06** and expires on **31/07/07**.
- (c) good tax exemption Order **No. 00364/06**.
- (d) this exemption Order granted is not transferable.
