(CAP 121)****THE CUSTOMS AND EXCISE (DETERMINATION OF DUTIES ON LOG
EXPORTS) ORDER 2006**

IN exercise of the powers conferred by section 7 of the Customs and Excise Act, I, HONOURABLE GORDON DARCY LILO, Minister of Finance and Treasury, do hereby make the following order:-

1. This Order may be cited as the Customs and Excise (Determination of Values on Log Exports) (Amendment) Order 2006 and shall come into force on the date of publication in the Gazette.

**THE CUSTOMS AND EXCISE (EXPORT DUTIES) (NO.) (AMENDMENT)
ORDER 2006**

IN exercise of the powers conferred by section 7 of the Customs and Excise Act, I, HONOURABLE GORDON DARCY LILO, Minister of Finance and Treasury, do hereby make the following order:-

1. This Order may be cited as the Customs and Excise (Export Duties) (Amendment) Order 2006 and shall come into force on the date of publication in the Gazette.
2. That part of the first schedule to the Customs and Excise Act, entitled EXPORT "CLASSIFICATION AND TARIFF" is hereby amended by deleting tariff items 4403.1110, 4403.1120, 4403.1130, 4403.1310, 4403.1320 and 4403.1330 and the words that appear in respect of each item in the corresponding columns and substituting therefore the following:-
