PRICE CONTROL ACT
(Cap, 64)**THE PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) ORDER 2006.**

IN exercise of the powers conferred by Section 4 and 6 of the Price Control Act, and after consultations with the Prices Advisory Committee, I, WALTON NAEZON, Minister of Commerce, Employment and Trade, do hereby make the following Order :-

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) Order 2006 and shall come into operation on 17 January 2006.
2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987 is hereby amended by deleting serial No. 13 thereof and substituting therefor the following -

13 PETROLEUM PRODUCTS
