**PRICE CONTROL ACT**  
( Cap. 64)**THE PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 2) ORDER 2006**

IN exercise of the powers conferred by section 4 and 6 of the Price Control Act, and after consultations with the Prices Advisory Committee, **I, FRANCIS BILLY HILLY**, Minister of Commerce, Employment and Trade, do hereby make the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 2) Order 2006 and shall come into operation on 1st July 2006.
2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987\* is hereby amended by deleting serial No. 13 thereof and substituting therefore the following -

**THE CONSTITUTIONAL OFFICES (TERMS AND CONDITIONS OF SERVICE) (DIRECTOR OF PUBLIC PROSECUTIONS) REGULATIONS 2006**

IN exercise of the powers conferred upon the Minister by section 3 of the Constitutional Offices (Terms and Conditions of Service) Act, the Minister hereby makes the following regulations -

| 1. | These Regulations may be cited as the Constitutional Offices (Terms and Conditions of Service) (Director of Public Prosecutions) Regulations 2006, and shall be deemed to have come into force with effect from 1st day of July, 2006.       | Citation                      |
| 2. | The term of office of the Director of Public Prosecutions shall be permanent unless otherwise specified in a contract of employment.   | Term of office                |
| 3. | The duties of the Director of Public Prosecutions shall be as laid down in section 91 of the Constitution.   | Duties                        |
| 4. | The Director of Public Prosecutions shall be paid a fortnightly salary of \$4,000.00.  | Salary                        |
| 5. | The Director of Public Prosecutions shall make contributions to the National Provident Fund as required under the provisions of Solomon Islands National Provident Fund Act  | NPF contributions<br>Cap. 109 |
| 6. | The Director of Public Prosecutions shall on first appointment receive an appointment grant of \$10,000.00.  | Appointment Grant             |
| 7. | The Director of Public Prosecutions shall be provided with an official residence free of rent or in the absence of a rent free accommodation and at the option of the officer, he shall receive a housing allowance of \$5,000.00 per month. | Housing                       |

| 8.      | The cost of water, gas, telephone and electricity provided to the residence of the Director of Public Prosecutions shall be charged to public funds and be paid for by the Government or at the option of the officer he shall receive a utilities allowance of \$1,300.00 per month. | Utilities                 |
| 9.      | The wages payable for the service of one domestic employee and a gardener shall be charged to public funds and paid for by the government.  | Domestic servants         |
| 10.     | The Director of Public Prosecutions shall be provided with a government vehicle free of charge and a fuel allowance of \$500.00 per month.  | Vehicle                   |
| 11.     | The Director of Public Prosecutions shall be entitled to leave at the rate of three and half days a month or forty-two days per annum for each year of completed service, which leave shall be taken during the year in which it accrues.   | Leave                     |
| 12. (1) | The Director of Public Prosecutions and members of his family shall be provided with sea or air passages as appropriate to his home village and return passages to Honiara when proceeding on annual leave.   | Passage                   |
| (2)     | In this regulation "home village" includes the home village of the spouse.  |                           |
| 13.     | The Director of Public Prosecutions shall be entitled to two return trips either by sea or air within Solomon Islands on compassionate leave per annum.   | Compassionate leave       |
| 14. (1) | The Director of Public Prosecutions shall be entitled to a daily subsistence allowance of US\$250.00 whilst on overseas travel or one-fifth of the daily allowance if the travel is externally funded.  | Overseas travel allowance |
| (2)     | Where the Director of Public Prosecutions is a guest of a host government, administration or agency and is not called upon to meet costs for accommodation and meals, he may claim subsistence allowance at the rate of one-fifth of his  |                           |

- allowance at the rate of one-fifth of his daily subsistence allowance entitlement
15. The Director of Public Prosecutions shall be entitled to a daily travel allowance of \$150.00 whilst on official travel within Solomon Islands. Local travel allowance
  16. (1) The Director of Public Prosecutions shall be entitled to travel first class on all official overseas visits. Class of travel (overseas visits)
  - (2) The spouse of the Director of Public Prosecutions shall be entitled to travel first class when accompanying the Director of Public Prosecutions on any official visit overseas and shall be entitled to claim subsistence allowance at the rate payable to the Director of Public Prosecutions in regulation 14(1).
  17. The Director of Public Prosecutions shall be entitled to clothing allowance of \$10,000.00 per annum. Clothing allowance
  18. The Director of Public Prosecutions shall be entitled to an entertainment allowance. The amount of the allowance shall be as determined by the Accounting Officer of the Ministry responsible for Justice and Legal Affairs. Entertainment allowance
  19. The Director of Public Prosecutions shall be entitled to medical treatment in accordance with the terms prescribed from time to time for public officers. Medical treatment
  20. The Director of Public Prosecutions shall be entitled to a Government guaranteed loan, the maximum amount of which shall not exceed his annual basic salary. Personal loan
  21. Subject to the provisions of Chapter F of General Orders, the Director of Public Prosecutions shall be entitled to claim baggage allowance. Baggage allowance
  22. Where the Director of Public Prosecutions dies whilst in office, the Government shall be responsible for all funeral expenses and all other expenses incidental thereto. Death during incumbency

23. The Director of Public Prosecutions shall be entitled to Miscellaneous  
benefits available to public officers under General Orders or benefits  
other regulations which are not covered by these Regulations.
24. The Director of Public Prosecutions shall be paid an Education  
education allowance of \$5,000.00 per annum. allowance
