**THE MEMBERS OF PARLIAMENT (ENTITLEMENTS) COMMISSION  
(AMENDMENT) REGULATIONS 2007**

IN exercise of the powers conferred by section 69B(2) of the Constitution, the Members of Parliament (Entitlements) Commission hereby makes the following regulations -

**Citation and commencement**                    1.        These Regulation may be cited as the **Members of Parliament (Entitlements) Commission (Amendment) Regulations 2007**, and shall come into force on the 1st day of April, 2007.

**Amendment of regulation 4 of the Members of Parliament (Entitlements) Regulation 2006**                    2.        Regulation 4 of the Members of Parliament (Entitlements) Regulation 2006 (hereinafter referred to as the "principal regulation") is hereby amended by inserting immediately after the definition of the term "Prime Minister" the following new definition -  
"Shadow Minister" means a member of Parliament who is appointed by the Speaker of Parliament upon recommendation by the Leader of Opposition to that office.

**Insertion of Regulation 10D**                    3.        The principal regulation is hereby amended by inserting immediately after regulation 10C the following new regulation as regulation 10D as follows -

**"Local subsistence allowance**                    10D.    All ordinary members of Who travel into Honiara from their Constituencies to attend a sitting of Parliament shall be paid a local subsistence allowance at a rate of \$250.00 per day."

**Insertion of Regulation**                    4.        The principal regulation is amended by inserting immediately after regulation 10D the following new regulation as regulation 10E as follows

**"Shadow Minister**                    10E. A Shadow Minister is entitled to an allowance of \$1,500 per month to cover accommodation costs, transport and incidentals related thereto".

Amendment of Appendix 5. Appendix A5 of the principal regulation is hereby amended by deleting the current Appendix A5 amounts to all zones so that the new constituency allowances for all zones now reads as follows -

Zone 1	\$16,000
Zone 2	\$15,800
Zone 3	\$15,600
Zone 4	\$15,400
Zone 5	\$12,200

Amendment of regulation 9(3)(b)(i) 6. Regulation 9(3)(b)(i) of the principal regulation is hereby amended by deleting the words "seventy five thousand dollars" and inserting regulation therefore the words "eighty thousand dollars".

Amendment of regulation 7. Regulation 16(2) of the principal regulation is hereby amended by inserting immediately after the word "touring" the words "overseas or".

Amendment of regulation 50(3) 8. Regulation 50(3) of the principal regulation is hereby amended by deleting the words "one-fifth of" and inserting immediately after the word "the" the word "full".

Amendment of regulation 31(1) 9. Regulation 31(1) of the principal regulation is hereby amended by deleting the figures "\$5,000" and "\$10,000" that appear therein and inserting the figures "9,000" and "\$15,000" respectively.

Amendment of regulation 31(3) 10. Regulation 31(3) of the principal; regulation is amended by inserting immediately after the word "employ" the words "one security guard."

Amendment of regulation 39(7) 11. Regulation 39(7) of the principal regulation is hereby amended by deleting the figure "\$3,000" and inserting instead the figure "4,000".

Amendment of regulation 39 12. Regulation 39(8) of the principal regulation is hereby amended by deleting the figure "\$1,500" and inserting instead the figure "2,000".

“State Owned Enterprises and Statutory Organizations (9) Chairman of State Owned Enterprises and Statutory Organizations who are members of Parliament shall be entitled to an allocation of one official Vehicle which shall be paid out of the Consolidated Fund for the official and private use of the Chairman whether or not their terms and conditions of engagement under the law they are appointed make provisions for the allocation of vehicles”.

Amendment of regulation 40(2) 14. Regulation 40(2) of the principal regulation is hereby amended by deleting the figures “4,000” and \$2,000” and inserting instead the figures “6,000” and “3,000” respectively.

Amendment of regulation 67) 15. Regulation 67 of the principal regulation is hereby amended by deleting the words “three to four” and inserting instead the word “eight”.

**THE PROVINCIAL ASSEMBLIES MEMBERS SALARIES AND  
ENTITLEMENTS (AMENDMENT) AWARDS 2007**

IN exercise of the powers conferred by section 25 of the Provincial Government Act, 1997, the Members of Parliament Entitlements Commission in consultation with the Minister of Provincial Government, hereby make the following salary and entitlement awards in respect of elected members of Provincial Assemblies -

1. CITATION

These Awards may be cited as the Provincial Assembly Members Salaries and Entitlements (Amendment) Award 2007.

2. COMMENCEMENT AND SOURCE OF FUND

- (a) These Awards shall come into force of 1st April, 2007, and shall replace Legal Notices No. 86 of 1998 and No. 71 of 2005.
- (b) The Awards are payable from the Consolidated Fund unless otherwise specified.

## 4. ALLOWANCES

## (a) Overseas Outfit Allowances

A member of a Provincial Assembly travelling overseas on official provincial duty shall be entitled to an overseas outfit allowance of \$3,000.00 provided that such an allowance shall be payable once only throughout the life of the assembly to each individual members from the Consolidated fund.

## (b) Overseas Subsistence Allowance

## (i) Overseas subsistence allowance for any provincial member travelling on an approved overseas visit

official duties shall be as follows -

Premier	US\$230.00
Deputy Premier	US\$220.00
Executive Members	US\$210.00
Members	US\$200.00

## (ii) If subsistence is wholly or partly met by the host government or agency, the allowance shall be one-fifth (1/5) of the above respective entitlement.

## (c) Local Subsistence Allowance

## (i) Except for ward tours, local subsistence allowance for any provincial member travelling within Solomon Islands on official provincial duty, shall be payable from provincial funds. The rates shall be as follows -

Premier	\$150.00
Head of Delegation	\$150.00
Deputy Premier	\$120.00
Executive Members	\$100.00
Members	\$ 80.00

## (ii) Local subsistence allowance is not payable for normal Executive Meeting attendance.

## 5. ADVANCES

A Provincial Assembly member may receive salary in advance provided that such an advance shall not exceed one month salary and that all previous advances have been repaid and such repayment have been recorded in the books of account

## 6. TRAVELLING EXPENSES

The following travelling expenses shall be payable to Provincial Assembly member -

- from
- (a) Travelling Expenses incurred by members while journeying from their home villages to the Provincial centre for the purpose of attending provincial assembly meetings and their return to their home villages shall be met from provincial funds. The expenses include the wife of each member and four children under the age of eighteen.
  - (b) Provincial Executive Members who reside at the provincial centre during the life time of an assembly, shall be entitled to travel to their home villages twice each calendar year and in an emergency (illness needing immediated treatment, or sudden death) accompanied by their wife, and up to four dependent children under the age eighteen, and the expenses incurred shall be paid from provincial funds.
  - (c) Provincial Executive Members residing in urban areas other than Provincial Centres, shall be eligible for land transport while engaged in official provincial business.
  - (d) Duty travel anywhere within Solomon Islands on official business will be met from Provincial Funds for all elected members and such travel will be in the most suitable economic manner available.
  - (e) Duty travel anywhere outside Solomon Islands on official business will be met from Provincial Funds for all elected members such travel will be in the most suitable economic manner available
  - (f) Where a Provincial Member is a guest of a host government, administration, agency or organisation and is not required to meet his accommodation and meal charges, he may claim one-fifth of the subsistence allowance applica-

## 7. ACCOMMODATION

- (a) Provincial Executive Members who reside at the provincial head-quarter during the lifetime of an assembly, shall be entitled to rent free accommodation of at least class IV type house, and that benefit shall be taxable.
- (b) Provincial Assembly members who reside in their own houses within the boundaries of the Provincial Headquarters shall be entitled to a housing allowance of \$1,000.00 per month. Provincial Assembly members who reside in rural areas (not within the boundaries of the Provincial Headquarters) are not entitled to housing allowance.

## 8. PREMIER'S PRIVILEGES

- (a) A Premier shall be entitle to all benefits accorded a member of the the Executive Committee or of the Assembly.
- (b) A Premier shall be provided free electricity, gas and water while in office under provincial assembly expenses.
- (c) A Premier shall be provided transport paid from provincial funds for the purpose of attending public functions in his official role as premier.
- (d) A Premier shall be entitled to have a domestic servant and a gardener at his official residence at provincial headquarters while he is in office, paid for from provincial funds.
- (e) A Premier residing in urban areas, other than provincial head-quarters, where an official vehicle and a driver is appropriate and where such privilege is fitting for a holder of such an office to have, shall be entitled to a vehicle and a driver provided under provincial funds.

## 9. WARD GRANT

All elected members shall be entitled to a ward grant of \$1,000.00 per annum during the life of a provincial assembly. No other touring allowance or travelling expenses will be paid in respect of ward touring.

## 10. TERMINAL GRANT

- (a) An elected member of a provincial assembly who has served for a period of 12 months will be entitled to a terminal grant of \$30,000.00 at the end of life of Provincial Assembly on a pro rata basis.
- (b) Subject to (a) and (c), hereof, where a member dies whilst in office, his terminal grant or any thereof, shall be paid to the surviving spouse or the oldest child surviving of the union as the case may be on pro rata basis.
- (c) A member who has served for less than 12 months, shall only be entitled to draw one-sixth of the full terminal grant of the life of the Assembly
- (d) Any outstanding debts, owing to the Government or Assembly shall be deducted from the terminal grant before payment is made to the member or under (b) above, as applicable.

## 11. EXGRATIA

- (a) An Exgratia payment shall be made to any person in respect of his membership of a Provincial Assembly for serving 2 consecutive terms or more of the Assembly. In this context the word "terms" where relevant will include the membership of the current provincial assembly he serve in any immediate membership in a preceding Assembly or another province.
- (b) Exgratia replaces Pensions awarded to persons in right or qualifying membership periods.
- (c) "Term" of two provincial memberships apply in instances when a Ward and member is transferred to another new province as a result of creating a new province from the existing one.
- (d) The exgratia payment shall be 30% of the gross salary of an ordinary member of the Assembly plus the terminal grant award.
