| <i>Accommodation allowances</i> | 4. | The accommodation allowances set out in Schedule 2 shall be paid to members of the Local Court for any day or part of the day when no accommodation has been or can be provided by the Government at the Government's expense. |
| <i>Subsistence allowances</i> | 5. | The subsistence allowances set out in Schedule 3 shall be paid to members of the Local Court for any day or part of a day when no meals have been or can be provided by the Government at the Government's expense. |

For sitting as President - \$120 per day or part thereof.
For sitting as Member - \$100 per day or part thereof.

SCHEDULE 2

Accommodation allowance for the President - \$100.00 per day or part thereof.
Accommodation allowance for the Members - \$100 per day or part thereof.

SCHEDULE 3

Subsistence allowance for the President - \$80 per day or part thereof.
Subsistence allowance for the Members - \$80 per day or part thereof.

**THE LAND AND TITLES (CUSTOMARY LAND APPEAL
COURT ALLOWANCES) REGULATIONS 2008**

5. The subsistence allowances set out in Schedule 3 shall be paid to members of the Customary Land Appeal Court for any day or part of a day when no meals have been or can be provided by the Government at the Government's expense.

SCHEDULE 1

1. The President shall be paid a sitting allowance of S130.00 per day or part thereof.
2. The other members shall be paid a sitting allowance of S110.00 per day or part thereof.

SCHEDULE 2

1. The President shall be paid an accommodation allowance of S100.00 per day or part thereof when no accommodation has been or can be provided by the Government at the Government's expense.
2. The other members shall be paid an accommodation allowance of S100.00 per day or part thereof when no accommodation has been or can be provided by the Government at the Government's expense.

SCHEDULE 3

1. The President shall be paid a subsistence allowance of S80.00 per day or part thereof when no meals have been or can be provided by the Government at the Government's expense.
2. The other members shall be paid a subsistence allowance of S80.00 per day or part thereof when no meals have been or can be provided by the Government at the Government's expense.

**PROVINCIAL GOVERNMENT ACT 1997
(No. 7 of 1997)**

The Guadalcanal Province 2008/2009 Appropriation Ordinance

AN ORDINANCE

TO

Appropriate Nine Million Seven Hundred and Twenty Nine Thousand Seven Hundred and Thirty Eight dollars to the services of the financial year ending 31st March 2009. Enacted by the Guadalcanal Provincial Assembly with the Assent of the Minister as follows:

1. This Ordinance may be cited as the Guadalcanal Province 2008/2009 Appropriation Ordinance 2008 and shall come into effect on the date it is assented to by the Minister of Provincial Government in accordance with Section 30 of the Provincial Government Act 1997.

2. The issue of the sum of Nine Million Seven Hundred and Twenty-Nine Thousand Seven Hundred and Thirty Eight dollars to be applied to the service of the financial year ending 31st March 2009.
3. The sum specified in the preceding section shall be appropriate for the supply of Heads and subheads specified in the schedule and in the amounts respectively in relation thereto.
