THE PROVINCIAL ASSEMBLIES ELECTION REGULATIONS 1987 NOTICE TO HOLD PROVINCIAL BYE-ELECTION FOR VATUKULAU WARD 7, GUADALCANAL PROVINCE 2008

IN exercise of the powers conferred by section 9 and 10 of the Provincial Government Act 1997 as read with Regulation 9 of the Provincial Assemblies Election Regulation 1987, I, **DAVID DAY PACHA**, Minister of Provincial Government hereby:-

- (i) Appoint the **25th Day of February 2008** as the date for holding of the Provincial Assembly Bye-Election for **Vatukulau Ward 7, Guadalcanal Province**;
- (ii) Appoint **Mr. John Stewart** to be the **Returning Officer** for the **Vatukulau Ward 7, Guadalcanal Provincial** Provincial Assembly Bye-Election; and
- (iii) Require that nominations in respect of candidates for the Election be delivered to the Returning Officer at the **Provincial Head quarter, Honiara**, not later than **4 o'clock** in the afternoon of **Monday the 28th Day of January, 2008**
