# IMMIGRATION ACT (Cap. 60)

#### Immigration (Fees and Forms) (Amendment) Regulations 2009

IN exercise of the powers conferred upon me by section 19 of the Immigration Act, I make these Regulations –

Citation and commencement

1. These Regulations may be cited as the Immigration (Fees and Forms) (Amendment) Regulations 2009, and commences on the date of publication in the Gazette.

First Schedule amended

2. (1) The First Schedule to Immigration (Fees and Forms) Regulations is amended in Form 10 by adding the following condition –

"In addition to the above condition, (insert name) hereby agrees to pay USD20 a day for every day he or she is in Solomon Islands after the expiration of his or her visa (becomes a prohibited immigrant)".

(2) The condition imposed by this regulation shall become a condition of any permit issued before the commencement of these Regulations.

Second Schedule repealed

3. The Immigration (Fees and Forms) Regulations are amended in regulation 13 by revoking the Second Schedule and substituting the following Schedule –
