#### THE PROVINCIAL ASSEMBLIES ELECTION REGULATIONS 1987

#### NOTICE TO HOLD PROVINCIAL ELECTIONS 2009

IN exercise of the powers conferred upon me by Sections 9 and 10 of the Provincial Government Act 1997 as read with Regulation 9 of the Provincial Assemblies Election Regulations 1987, I MANASSEH MAELANGA, Minister of Provincial Government and Institutional Strengthening hereby:

- (i) appoint the 29th Day of October 2009, as the date for holding of Provincial Assembly Elections in the following Provincial Wards:-

Ward 5, Tulagi, Central Province  
 Ward 14, Star Harbour North, Makira Ulawa Province  
 Ward 6, South Ranogga, Western Province and  
 Ward 13, Kerepangara, Choiseul Province

- (ii) appoint as Returning Officers:

- (a) Mr Jonathan Bana for Western Province  
 (b) Mr Commins Ikioa for Makira Ulawa Province  
 (c) Mr John Rapemora for Central Province

- (iii) Confirm the appointment of Mr Geoffrey Pakipota as Returning Officer for Choiseul Province as signed by me on 26th March 2009.
- (iv) Require that nominations of candidates for each of the by elections be delivered to the Returning Officers concerned not later than four o'clock on Thursday 1st October 2009.
