**THE GUADALCANAL PROVINCE BASIC RATE (AMENDMENT)
ORDINANCE 2010**

**AN ORDINANCE TO AMEND THE GUADALCANAL PROVINCE
BASIC RATE (AMENDMENT) ORDINANCE 1987**

ENACTED by the Guadalcanal Provincial Assembly with the assent of the Minister of Provincial Government and Institutional Strengthening as follows:

1. This Ordinance may be cited as the Guadalcanal Basic Rate (Amendment) Ordinance 2010 and will come into effect when assented to by the Minister in accordance with section 30 of the Provincial Government Act 1997.

2. Schedule 1 of the Guadalcanal Province Basic Rate Ordinance 1985 is repealed in its entirety and replaced by –
