**PRICE CONTROL ACT
(Cap. 64)**

**THE PRICE CONTROL (APPLICATION TO GOODS AND
RESTRICTION OF PRICES) (AMENDMENT) (No.8) ORDER 2010**

IN exercise of the powers conferred upon me by sections 4 and 6 of the Price Control Act, I make this Order –

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No.8) Order 2010 and shall come into operation on 1st December, 2010.

2. The Price Control Order (Application to Goods and Restriction of Prices) Order 1987 (L/N 47/87 is amended in schedule 3 by revoking Serial No.13 (Petroleum Products) and substituting the following –
