# DEPORTATION ACT (CAP. 58)

#### **DEPORTATION - STATEMENT OF FACTS**

WHEREAS YOU, IOANE KELI MANASAU is a person issued with Resident Permit under section 8 (1) of the Immigration Act, but such permit has been cancelled on the 17th July 2013 by the Director of Immigration and therefore you have ceased to be the holder of a valid Residence Permit or any other permit issued under the Immigration Act (Cap.60), or any other laws of Solomon Islands therefore your presence in Solomon Islands is now unlawful.

WHEREAS YOU have conducted yourself in a manner prejudicial to the peace and good order in Solomon Islands therefore have been declared by the Government as a prohibited Immigrant under section 11(1) of the Immigration Act (Cap.60).

AND TAKE NOTICE that the particulars of the facts against you, IOANE KELI MANASAU or upon which this ORDER is made are as follows –

- 1. That you a foreign national from the Republic of Fiji Islands.
- 2. That you entered the country is reference to Imm 073/07 on a Residence Permit that was cancelled by the Director of Immigration on the 17th July 2013, yet you continue to reside illegally in Solomon Islands without a valid Resident Permit.
- 3. That you were found and contine to reside illegally in Solomon Islands pursuant to section 11(1) as read with section 6(2) of the Immigration Act (Cap.60).

NOW THEREFORE pursuant to section 4(a) of the Deportation Act (Cap.58) as read with section 5(1) of the same Act and having regard to the particulars of facts stated above, I hereby make this Order against you, IOANE KELI MANASAU to be deported and leave Solomon Islands immediately and not re-enter this country.

AND pursuant to section 7(2) of the Deportation Act, I hereby authorise that this order be served on IOANE KELI MANASAU and further direct that IOANE KELI MANASAU to be placed onboard any ship or aircraft leaving Solomon Islands.

AND I further authorise and direct the Officer-In-Charge of the Honiara Rove Correctional Services or a Police Station in Solomon Islands to detain IOANE KELI MANASAU until arrangements are completed to place him on board any ship or aircraft.
