**CHOISEUL PROVINCE BUSINESS LICENCE (FEES)
REGULATIONS 2016**

The Choiseul Provincial Assembly makes the following Regulations under section 32 of the Choiseul Province Business Licence Ordinance 2011:

Citation and commencement 1. These Regulations may be cited as the Choiseul Province Business (Fees) Regulations 2016 and commence on the date they are published in the *Gazette*.

Interpretation 2. In these Regulations -

“alluvial miner’s permit issued under section 50 of the Mines and Mineral’s Act (Cap.42);

“felling licence” means a licence granted under section 5 of the Forest Resources and Timber Utilisation Act (Cap.40);

“golddealer’s licence” means a licence issued under section 55 of the Mines and Mineral’s Act (Cap.42);

“mining lease” means a mining lease granted under section 36 of the Mines and Mineral’s Act (Cap.42);

“reconnaissance permit” means a permit issued under section 13 of the Mines and Mineral’s Act (Cap.42).

Fees 3. For section 32 of the Ordinance, the fees for a licence are set out in the Schedule.

Repeal 4. The Choiseul Province Business Licence (Fees) Regulations 2011 are repealed.
