**PRICE CONTROL ACT  
(Cap. 64)****PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION  
OF PRICES) (AMENDMENT) (NO. 19) ORDER 2017**

I, **Hon. William Bradford Marau**, Minister for Commerce, Industry, Labour and Immigration, under section 4 and 6 of the *Price Control Act* (Cap.64), make the following Order:

1. This Order may be cited as the Price Control (*Application to Goods and Restriction of Prices*) (*Amendment*) (*No. 19*) Order 2017.
2. This Order commenced on the date it is published in the *Gazette*.
3. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Legal Notice No. 47 of 1987) is amended in Schedule 3 by deleting serial No. 13 on PETROLEUM PRODUCTS and substituting the following:

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 19) Order 2017, and commences on 15 September 2017.
2. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Legal Notice No. 47 of 1987) is amended in Schedule 3 by deleting serial no. 12 (Petroleum Products) and substituting the following:

**“12. LIQUID PETROLEUM GAS**
