**PRICE CONTROL ACT  
(CAP. 64)**

**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION  
OF PRICES) (AMENDMENT) (NO. 18) ORDER 2017**

I, **Hon. Manasseh Maelanga**, Acting Minister for Commerce, Industries, Labour and Immigration, under section 6 of the *Price Control Act* (Cap. 64), make the following order:

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 18) Order 2017, and commences on 1 August 2017.

2. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Legal Notice 47 of 1987) is amended in Schedule 3 by deleting serial no. 13 (Petroleum Products) and substituting the following:

**“13. PETROLEUM PRODUCTS**

	<b>Wholesale</b> (Maximum price in cents per litre)	<b>Retail</b> (Maximum price in cents per litre unless otherwise specified)
<b>PETROLEUM PRODUCT</b>		
(a) Petroleum motor spirit (PMS)	590.05	763.6
(b) Distillate (ADO)	587.17	760.2
(c) Kerosene (KERO)	548.79	(Maximum percentage mark-up)  – cost into store plus 15% for sales – cost into store plus 20% for break bulk sales”
