**Mines and Minerals (Royalties) (Amendment)  
Regulations 2017**

In exercise of the powers conferred by section 80 of the *Mines and Minerals Act (Cap. 42)*, the Minister for Mines, Minerals and Rural Electrification makes the following Regulations:

**Part 1            Preliminary matters**

**1            Citation**

These Regulations may be cited as the Mines and Minerals (Royalties) (Amendment) Regulations 2017.

**2            Commencement**

These Regulations commence on the date of publication in the *Gazette*.

**3            Regulation Amended**

Schedule 1 to the *Mines and Minerals (Royalties) Regulations 2011* (LN 56 of 2011) is amended by inserting the following after clause 2A:

“2B. The remaining amount of \$3,582,082 in the Fund in respect of Gold Ridge Mine on the date the *Mines and Minerals (Royalties) (Amendment) Regulations 2017* commence must be distributed in the following manner:

- (a) \$40,000 each is to be paid to Kolobisi Tailings Dam Association and Matepono Downstream Association;
- (b) 70% of what is left after the distribution under paragraph (a) is shared as follows:

Chacha	10%
Chavuchavu	10%
Roha	10%
Sutahuri	10%
Kaokao	10%
Kalipali	10%
Salasivo	10%
Sabaha	10%
Sarahi	10%
Koenihao	10%

(c) the remaining 30% is shared as follows:

Rausere	16.66%
Charana	16.66%
Halisia	16.66%
Soroboilo	16.66%
Vatuviti	16.66%
Lasi	16.66%

## **IMMIGRATION ACT 2012**

### **DEPORTATION ORDER**

I, **William Bradford Marau**, Minister for Commerce, Industry, Labour and Immigration, under section 31(1) (b) and (c) and of the *Immigration Act 2012*, order the deportation of **Nguyen Van Thang** on the following grounds:

(a) he is an unlawful citizen under section 28 of the Act;

- (b) there is a character concern about the unlawful citizen, under section 23; and
- (c) he has been given reasonable opportunity to voluntarily depart Solomon Islands and it is reasonable to conclude that the person is unlikely to voluntarily depart Solomon Islands.
